#### FIRST RESOLUTION

That pursuant to the Registered Clubs Act:

(a) The members hereby approve and agree to expenditure by the Club in a sum not exceeding \$5,000.00 until the next Annual General Meeting of the Club for the following activities of directors.

(i) The reasonable cost of a meal and beverage for each director immediately after a board or committee meeting on the day of that meeting when that meeting corresponds with a normal meal time.

(ii) Reasonable expenses incurred by directors in travelling to and from directors meetings or other duly constituted committee meetings as approved by the board from time to time on production of invoices, receipts or other proper documentary evidence of such expenditure.

(iii) Reasonable expenses incurred by directors in relation to such other duties including entertainment of special guests of the Club and other promotional activities performed by directors which activities and the expenses there from are approved by the board before payment is made on production of receipts, invoices or other proper documentary evidence of such expenditure.

(b) The members acknowledge that the benefits in paragraph (a) above are not available to members generally but only for those who are directors of the Club.

### SECOND RESOLUTION

That pursuant to the Registered Clubs Act:

- (a) The members hereby approve and agree to expenditure by the Club in a sum not exceeding \$5,000.00 for the professional development and education of directors until the next Annual General Meeting and being:
  - (i) The reasonable cost of directors attending ClubsNSW Annual General Meeting, seminars, lectures, trade displays and other similar events as may be determined by the Board from time to time:
  - (ii) The reasonable cost of directors attending other Registered Clubs for the purpose of viewing and assessing their facilities and methods of operation provided such attendances are approved by the Board as being necessary for the betterment of the Club.
- (b) The members acknowledge that the benefits in paragraph (a) above are not available to members generally but only for those who are directors of the Club.

### THIRD RESOLUTION

That the pursuant to the Registered Clubs Act the members approved that payment of the following Honoraria for the forthcoming year:

- (i) President's Honorarium \$2,200
- (ii) Vice President's Honorarium \$ 660 each
- (iii) Director's Honorarium \$ 440 each

### NOTES TO MEMBERS – CONSIDERATION OF ALLOWANCES

These notes are to read in conjunction with the proposed Resolutions:

1. The First Resolution is to have the members in General Meeting approve an amount no greater than \$5,000.00 for expenditure by the Club in relation to duties performed by the Club's directors.

- 2. The Second Resolution is to have members in General Meeting approve an amount no greater than \$5,000.00 for the expenditure by the Club for directors to attend seminars, lectures, trade displays and other similar events including the Clubs NSW Annual General Meeting and to visit other clubs to enable the Club's Board to be kept abreast of current trends and developments which may have a significant bearing on the nature and way in which the Club conducts its business.
- 3. The Third Resolution is to have the members approve Honoraria for the Club President and Directors.

### NOTICE OF ORDINARY RESOLUTIONS - CLUB MEMBERSHIP FEES 2024-2025

That pursuant to the Rules of the Club:

The members approve and agree to the Board of Directors determining the Club Membership Subscription Fees for the 2024-2025 financial year.

### NOTES TO MEMBERS – CLUB MEMBERSHIP FEES 2024-2025

The Club usually conducts it's Annual General Meeting in September each year. It is too late to set the current year's subscription fees because the Club renewal period has ended. It is too early to set the following year's fees because the fees from Bowls NSW Limited and Newcastle District Bowling Association have not been determined.

For the Club to comply with it's Rules it is recommended members approve the decision be made by the Board of Directors each year.
